Meeting called to order and roll call

Board of Education President, Mr. Hoch, called the meeting to order at 6:47 p.m.

Notice of Meeting

The meeting was properly noticed by posting the notice of the meeting at the Durand Public Library, at the Durand High School, and at Caddie Woodlawn.

Executive Session 19.85(1)(a) and 19.85(1)(f)

Motion made by Mrs. Hoyt and seconded by Mrs. Myers to convene into executive session in accordance with state statute 19.85(1)(a) and 19.85(1)(f). Motion carried by a unanimous roll call vote.

Motion made by Mr. Wittig and seconded by Mrs. Myers to expel the student from the School District of Durand through the age of twenty-one. Student will have the option for completion of the necessary credits toward graduation. Student will also have the option for early reinstatement at the beginning of the first semester of the 2009-10 school year subject to all of the following conditions: (1) Student must enroll and satisfactorily complete "Corrective Thinking" counseling at the family's expense; (2) Student must maintain full participation and cooperation in his educational programming as prescribed by his Individual Education Program (IEP), including appropriate social behaviors and stress management; (3) Student must adhere to all sanctions prospectively imposed by Pepin County Human Services or any other agency as a result of this incident; (4) Participation in an AODA (Alcohol and other Drug Abuse) Assessment at the family's expense; and (5) Upon the student's return to the school building, the student will comply with requested urine analysis testing on either a random or suspicion basis until the time of his graduation. It is further ordered that the student be precluded from being present on school premises for any purpose during the term of the expulsion, including attendance at all co-curricular activities and other events on school premises, without regard to whether such activities or events are otherwise open to the general public, unless the student has obtained prior administrative approval to do so. Motion carried by a unanimous roll call vote.

Motion to Return to Open Session

Motion made by Mrs. Hoyt and seconded by Mr. Wittig to return to open session. Motion carried by a unanimous voice vote.

Adjournment

Motion made by Mr. Pelke and seconded by Mr. Wittig to adjourn. Motion carried by a unanimous voice vote.
